Mr. Camacho Flores was assessed a fine of \$200.00 for failing to maintain a straight course going down the backstretch causing interference to a horse outside of him while aboard, 'Cat N Bird', in the first race on Sunday, April 30, 2017 in ruling number EMD17-038.

After reviewing the videos and taking the testimony of the riders involved the board of stewards determined that #5 Top Kitty Kat did drift in slightly down the lane but there was always running room and it did not cost #3 Luck Out the opportunity of a better placing, therefore no change was made to the official order of finish. The original order of finish was not changed, 5-1-3-7-4-6.
