Report for Sunday, June 25, 2017
Track Condition: Fast

A stewards' ruling conference was held with jockey J.C. (John Carlos) Estrada for an incident that occurred late in the stretch in the tenth race on June 18th, 2017. After hearing testimony and reviewing the video of the race, the stewards determined that Mr. Estrada caused his horse to veer out under left hand whipping interfering with an outside horse. Mr. Estrada was fined \$200.00 for careless riding in ruling number EMD17-078.

Race 3

Following the running of the race the stewards posted the inquiry sign due to contact down the lane involving the winner, #1 Chorizo Y Papas, ridden by Kevin Orozco, and the second place finisher, #3 Gravel, ridden by Isaias Enriquez. Isaias Enriquez, the rider of #3 Gravel, also lodged an objection against #1 Chorizo Y Papas alleging interference down the stretch. After reviewing the videos and taking the testimony of the riders involved the stewards determined that down the lane #3 Gravel, was moving through on the rail inside of #1 Chorizo Y Papas when #1 Chorizo Y Papas drifted in initiating contact with #3 Gravel causing severe bumping between both horses for several strides. The stewards decision was that this incident did cost #3 Gravel the opportunity of a better placing as he regained his stride again late and was beaten a short margin. Therefore, the stewards disqualified #1 Chorizo Y Papas and placed him second behind #3 Gravel. A conference notice was issued to jockey Kevin Orozco to appear before the board of stewards for a film review. The official order of finish is as follows: 3-1-7-4-5-6-8.
