Race 6

Following the running of the race the stewards posted the inquiry sign due to an incident down the stretch involving the second place finisher #5 One More Orman, ridden by Rocco Bowen, the winner #2 Dustin's Passion, ridden by Jose Zunino, and the fifth place finisher #6 Ace On The River, ridden by Kevin Orozco. The rider of #6 Ace On The River also lodged an objection against #5 One More Orman and #2 Dustin's Passion following the race. After reviewing the videos and taking the testimony of the riders involved the stewards determined that #5 One More Orman drifted in causing #6 Ace On The River to steady between #2 Dustin's Passion and #5 One More Orman while #2 Dustin's Passion kept a straight path at the time the incident occurred. The stewards felt that the incident cost #6 Ace On The River the opportunity of a better placing as he was beaten a very short margin for fourth position. The stewards

disqualified #5 One More Orman from second and placed him in fifth position behind #6 Ace On The River. The final official order of finish was 2-1-8-6-5-3. A conference notice was issued to jockey Rocco Bowen to appear before the board of stewards for a film review.
