A ruling conference was held with jockey Gary Wales at which time testimony was heard and a review of the video was conducted. Accordingly, Gary Wales is hereby assessed a fine of \$200.00 for failing to maintain a straight course down the stretch causing interference in the sixth race on Sunday, May 6, 2018, while aboard #2 O Rally. This was addressed in ruling number EMD18-018.

A ruling conference was held with jockey Austin Solis at which time testimony was heard and a review of the video was conducted. Accordingly, Austin Solis is hereby assessed a fine of \$500.00 for failing to make sufficient effort to maintain a straight course going into the turn while aboard, Capital Expense, in the sixth race on Friday, May 11, 2018. This was addressed in ruling number EMD18-019.

After reviewing the videos and taking testimony from the riders involved, the stewards determined that #7 My Endless Love did drift in making contact with #4 Blushing Ann, however the decision of the board of stewards was that the contact did not cost #4 Blushing Ann a better placing, therefore no change was made to the original order of finish. The official order of finish remains 3-7-8-5-1-2-4-6.
