A conference notice was prepared for Leonel Camacho-Flores for an incident leaving the starting gate.

Race 8

Following the running of the race the stewards posted the inquiry sign due to an incident in the stretch involving second place finisher #7 Time 'N Time Again, ridden by Julien Couton, and #12 Frolic And Detour, ridden by Eswan Flores. After reviewing the videos and the stewards determined that down the

lane #7 Time 'N Time Again came in abruptly near the eighth pole causing #12 Frolic And Detour to clip heels and unseat his rider. Therefore, the stewards disqualified #7 Time 'N Time Again from second place and declared him unplaced. The original order of finish of 8-~~7~~-4-5-6-9-2-3-11-10 was changed to 8-4-5-6-9-2-3-11-10 (7 unplaced, 12 DNF). A conference notice was issued to jockey Julien Couton to appear before the board of stewards for film review.
