Immediately following the running of the race, a Stewards Review was initiated, to investigate the stretch drive involving #1 & #2. During the Review, Trainer Candace Cryderman called the Board Of Stewards and she asked if we were looking at the incident, she was told yes, and she did not lodge an objection. Jockey Javier Matias, also did not lodge an objection. Upon conclusion of the Stewards Review, it was determined that while #1 Tap The Bank, did come out slightly, and #3 Coastal Buzz came in slightly and #2 Senior Fabuloso altered course, #2 had room to have remained in that lane, all the while #1 Tap The Bank was clear. Secondly, #1 came down but #2 started checking well before the

hole was closed very near the wire. Accordingly the Stewards Review was not escalated to an inquiry, and the original order was declared official. Mr. Anaya was ordered to see the Stewards for film review.

A ruling conference was held with jockey Jose Zunino in which a warning due to mitigating circumstances was issued for use of improper language in ruling EMD21-046.

A ruling conference was held with jockey Julien Couton in which he was fined \$250.00 for failure to maintain a straight course down the backside in ruling EMD21-047.

A ruling conference was held with jockey Heribert Martinez in which he was fined \$100.00 for failure to follow the Outriders instructions in ruling EMD21-048.
