Race 1 Stewards Review/ No Change

A steward's review was made to look into an incident in the vicinity of the 7/16ths pole involving the unofficial second place finisher #1 Trumped and the unofficial winner #2 Brady Boy. It was determined that after breaking slowly the #1 was running greenly and pulling his way into third, closing on the inside the #2 & #5, who was not involved. The #2 may have come over slightly when switching leads, but the #1 was rank and in very tight quarters, it appeared that the #1 was attempting to get through at the point of the turn without establishing his position, didn't have room to switch leads & came out when the rider took hold of the horse, broke stride and lost ground. Blame was apportioned equally to both the rider and horse (#1) and as such the review was not escalated to an inquiry, and the original order of finish was declared official.

Race 6 Stewards Review/ Inquiry/ DQ

Immediately following the running of the race, a steward's review was initiated followed directly by the inquiry sign being hung to investigate an incident at the head of the lane involving the #4 Northern Blend and his rider Alejandro Anaya, the #6 JC Express and his rider Clayan Millwood and the #1 Mayhem And Chaos and his rider Kevin Radke. The #1 was quickly taken out of the equation as he maintained his path, the #4 however came out taking the path of, and forcing the rider of #6 to check, it was determined that the #6 was cost the chance of a better placing. The inquiry was extinguished and the original order of finish of 1-5-3-~~4~~-6-2 was amended to 1-5-3-~~6~~-4-2 and declared official.
