Race 5

Following the running of the race the stewards posted the objection sign due to an incident near the three sixteenths pole involving first place finisher #3 Battle Point Red, ridden by Kevin Orozco, and third place finisher #2 Chipinzee, ridden by Gary Wales, After taking testimony from both riders and reviewing the videos the stewards determined that #3 Battle Point Red ducked out sharply after being asked with left hand pressure causing severe bumping with #2 and that this interference cost #2 the opportunity of a better placing as the #2 was beaten a long nose for third therefore, the stewards disqualified #3 from first place and placed him third. The original order of finish of 3-8-(2)-5-6-4-7 was changed to 8-(2)-3-5-6-4-7. A conference notice was issued to jockey Kevin Orozco to appear before the board of stewards for film review.

Race 7

Following the running of the race the stewards posted the inquiry sign due to an incident near the eighth pole involving fifth place #3 National Browser ridden by Gary Wales, and sixth place finisher #1 Merveilluse, ridden by Patrick Henry. After taking testimony from both riders and reviewing the videos the stewards determined that #3 National Browser was coming in only slightly under heavy right handed pressure, switched leads and came in abruptly causing #1 to check severely due to a lack of room that had existed before, and that this interference cost #1 the opportunity of a better placing as the #1 was making a strong move. Therefore, the stewards disqualified #3 from fifth place and placed him sixth. The original order of finish of 7-2-4-6-~~3~~-(1)-5 was changed to 7-2-4-6-(1)-~~3~~-5. A conference notice was issued to jockey Gary Wales to appear before the board of stewards for film review.
