Race 8

Following the running of the race an objection was lodged via quick official by the rider of #6 Rings Of Saturn, Ryan Barber. It was initially reported as #6 against #5 Ididntseethatcomin at head of the lane, as soon as we began to review the replays it was immediately clear that was not a valid objection, we double checked with the outrider, who claimed that was what Mr. Barber requested. It was actually #6 against #2 Gordon Anthony and his rider Julien Couton, inside 1/16 pole. No change was made in this instance, as we felt #6 was fouled, but was not cost chance of better placing. We also reviewed bumping incidents between #3 American Buddha and, #5 ididntseethatcomin. We felt that while #3 did come out very slightly, causing the initial contact at the head of the lane, we believed that any contact after that, #5 was the aggressor and was out finished by #3. Accordingly, no change was made to the original order of finish and was declared official. Julien Couton, Heribert Martinez & Javier Matias were sent to the Film Analyst for films review.

A ruling conference was held with jockey Javier Matias regarding the seventh race on 8/7/2021 in which he was fined \$100 for failure to maintain a straight course in ruling EMD21-040.
