As a result, no change was made to the order of finish and was declared official. A conference notice was prepared for Juan Gutierrez.

Jockey Julian Couton discovered that after being in post parade for 10 minutes, he did not have a riding crop. The Starter radioed explaining that a replacement crop that was not available at the starting gate,

so the chase truck was sent to the jocks room to get a replacement. Fortunately this only caused a 3 minute delay in post. A conference notice was prepared for Julien Couton.
