Race 2

Following the running of the race, the rider of fourth place finisher #5 Doin Double Time Alex Anaya lodged an objection alleging interference leaving the starting gate involving the first place finisher #4 Helaman, ridden by Heribert Martinez. After reviewing the videos and taking testimony from the riders involved the stewards determined that #5 Doin Double Time broke slowly while #4 Helaman broke outwards slightly and #6 Gambler's Account ridden by Ryan Barber broke in slightly coming together in the space not occupied by #5 Doin Double Time due to his breaking slowly. The Stewards decision was that #5 was not cost the opportunity at a better placing. Therefore the Stewards did not make any change to the original order of finish. The official order of finish is as follows: 4-1-6-5-2-3.

Race 7

Following the running of the race the Stewards posted the inquiry sign due to an incident near the sixteenth pole involving contact between second place finisher #2 Bella Mia, ridden by Juan Gutierrez, fourth place finisher #4 Best Of Me, ridden by Franklin Ceballos, and third place finisher #5 Paddy's Secret, ridden by Javier Matias. There was also a jockey objection lodged by Franklin Ceballos, the rider of #4 Best Of Me, against #2 Bella Mia and #5 Paddy's Secret. After reviewing the videos and taking testimony from the riders involved, the Stewards determined that at the sixteenth pole #2 Bella Mia ducked out sharply making contact with #4 Best Of Me, who was between #2 Bella Mia and #5 Paddy's Secret and had to check sharply. #2 Bella Mia was disqualified from second to fifth place for costing #4

Best Of Me the opportunity of a better placing. The original order of finish of 9-2-1-5-4-3-8-6-7 was changed to 9-1-5-4-2-3-8-6-7 and declared official. A conference notice was issued to jockey Juan Gutierrez to appear before the Board Of Stewards for a film review.
