Immediately following the running of the race the inquiry sign was lit to look into an incident in the lane involving both the unofficial winner and second place finisher #2 Affirm Chief #1 Barbarian, contact in the lane. After reviewing the replays and speaking to both riders involved it was decided that the contact was caused by the #1 and since he was outrun by the #2, no change was made to the original order of finish and declared official.

Race 8

Immediately following the running of the race the inquiry sign was lit to look into an incident in the lane involving the unofficial winner #3 El Chavo Del Ocho, and unofficial fourth place finisher #4 Heredia Boxer and unofficial sixth place finisher #5 Mojave. After reviewing the replays it was determined that while the #3 did come out, he was clear and the maneuver did not cost the #4 or #5 the chance of a better placing, and as such no change was made to the original order of finish, and was declared official.
