**Race 1 INQUIRY OBJECTION No Change**

Following the running of the race the inquiry sign was lit, followed by a trainer's objection by the trainer of the #3 against the #2 at the break. After reviewing the video replays it was determined that while the #2 did come out the first jumps leaving the starting gate, the rider made sufficient effort to maintain a straight course, as a result the objection sign was extinguished and no change was made to the original order of finish and declared official.

**Race 3 INQUIRY DQ**

Immediately following the running of the race the inquiry sign was lit denoting the unofficial second place finisher #7, Knightline, to look into an incident at the start. After reviewing the replays it was

determined that #7 came over without proper clearance fouling the #6 who was cost the chance of a better placing. The inquiry sign was extinguished and the original order of finish of 5-7-3-8-2-6-1 was amended to 5-3-8-2-6-7-1 and declared official.

**Race 5 INQUIRY DQ**

Immediately following the running of the race the inquiry sign was lit denoting the #10. After reviewing the video replays it was determined that #10 be disqualified from fourth and placed tenth for interference near the 3\16ths pole, placing it behind the #3 who was cost the chance of a better placing doe to the foul. The inquiry sign was extinguished and the original order of finish of 11-1-4-10-5-9-8-7-2-3 was amended to 11-1-4-5-9-8-7-2-3-10 and declared official.
