Race 3 Inquiry

Immediately following the running of the race the inquiry sign was lit, and the first three finishers were lit to investigate contact late in the lane between the unofficial winner #6 Besame Mucho & second place finisher #5 Socal Red. After reviewing the replays and speaking to the riders involved, it was determined that the #2 was not involved, and contact between the #6 & #5 was mutual, as such no change was made, and the results declared official.

Race 6 Inquiry

Immediately following the running of the race the inquiry sign was lit to investigate the break of the outside four horses. After reviewing the replays it was determined that the #5 was found to be most at fault, but ran last, and as such no change was made to the order of finish, and declared official.

Race 7 Inquiry

Immediately following the running of the race, the inquiry sign was lit to investigate an incident going into the turn in the vicinity of the 3/8 pole. After reviewing the videos which show five horses racing in tight quarters going into the turn and the number 3 horse Reservoir was lugging out and failed to switch leads, not allowing him to fall into the turn properly which tightened the room up more causing the number six horse Driveway to take up. No change was made to the order of finish.

Race 8 Inquiry

Following the running of the race, the inquiry sign was hung to look-into the stretch run between the first two finishers, #8 Fun City and #6 Let George Do It. After reviewing the videos, it was determined that the #6 who finished second came out and caused the interference to the winner, Fun City. No change was made to the original order of finish.
