Race 3

After technical difficulties with the photo finish and the video replays the correct order of finish was posted to the tote board. The photo finish strip was slow to load and we requested that the pan shot be ran at half speed at the wire to ascertain the order of finish. The video system chose to go out of order at that time, immediately following this failure of the video system, a strip was produced by the photo finish system, and unfortunately it loaded the prior race as well as the race in question. We redid the rundown and inadvertently posted the incorrect order of finish, off of the incorrect strip. Upon noticing the error we contacted the announcer asking patrons to hold all tickets, and both Tote and Mutual's

departments to see how to correct going official with the incorrect order of finish. Working with them, we had the order of finish and payouts corrected.

Race 7

Stewards Review turned into rider objection by #4 That's My Story's rider Leslie Mawing against #1 Guarding Elk Camp and his rider Julien Couton for interference in the lane. After speaking to the riders involved and reviewing the video replays, it was determined the #6 Shady Retreat came in while clear forcing #1 to alter course to his outside into an opening between #4 and #6, with #5 Maybee A Diva on the outside, who maintained a straight course. At this point #4, while in tight quarters came in causing contact with #1. After which the #4 lost ground, however she initiated the contact. Accordingly the Review/Objection signs were extinguished and the original order of finish was declared official. Alex Anaya to film review with the Stewards.
