Race 3 No Change

The Stewards looked into an incident in the vicinity of the 3/8 pole, after reviewing it was determined that the #5 came over without proper clearance possibly fouling the #3 & #1, however the #3 & #1 outran the #5, as such no change was made.

Race 4 No Change

The Stewards looked into an incident late in the drive involving the #7 and the #6. The #7 fouled the #6 late, as stated, however the #6 was not cost the chance of a better placing, and the results were declared official.

Race 6 Inquiry No Change

Following the running of the race the inquiry sign was lit to look into an incident involving the #4 & #5 in the vicinity of the 3/8 pole. After reviewing the replays and attempting to speak to the riders involved it appeared that the #5, depending on the view, may have made it to the hole, other views appeared to

show the #5 did not make it. As a result, no change was made to the original order of finish and declared official.
