Race 6 Inquiry / Trainers Objection/ DQ

Following the running of the race the inquiry process was started followed by an objection by Blaine Wright, Trainer of the unofficial third place finisher #2 State Of The Union against the unofficial winner #5 Barbarian. After reviewing the video replays and speaking to the riders involved, it was determined that the #5 moved from about 2 widths off the rail at the head of the lane, finishing about 10 lengths

from the rail, while under left-handed crop. The #2 was closing from behind and going nearly head-to-head, losing much ground, due to the #5 failing to maintain a straight course while coming out, costing the #2 a chance of a better placing, as the first three finishers were only separated by a head. The #5 Barbarian and his rider Luis Negron were disqualified from first to third for interference in the lane. The objection sign was extinguished and the original order of finish 5-7-2-6-3-4 was amended to 7-2-5-6-3-4 and declared official.

Race 7 Trainers Objection/ No Change

Following the running of the race an objection was lodged by Cliff Balcom Trainer of the #7 Friso Frills against #1 Slice Of Pie for interference in the vicinity of the ¼ pole. Ater reviewing the video replays and speaking to the riders involved, it was determined that no foul occurred. As such, the objection sign was extinguished, and the results declared official.
