LATE JOCKEY CHANGES: None

Race 1

Mutuals mistakenly put first post at 1:28PM instead of the intended 1:38PM, causing the receiving barn to send the field over before the error was discovered. We had the Paddock Judge delay saddling until about 17 minutes, to try and get back on schedule with the minimum disruption for the horses/horsemen .

Race 2

Due to only 4 participants, show wagering was removed from this race.

Race 4

Immediately following the running of the race the inquiry sign was lit indicating the unofficial winner #6 Quagmire Magic ridden by Kevin Krigger and unofficial second place finisher #5 Ain't No Sissy ridden by Luis Reyes, to look into incidents in the vicinity of the quarter and sixteenths poles. After speaking to both riders and reviewing the video replays. It was determined that near the quarter pole #6 came out bumping #5 twice, knocking him off stride. The two horses then dueled from that point on, with the #6 gaining a fleeting advantage mid-stretch, only to have the #5 close back in, to be beaten only a nose. Accordingly due to the very short distance between the horses, we disqualified the #6 Quagmire Magic from first place placing him behind the fouled #5 Ain't No Sissy. The original order of finish ~~6-5~~-1-2-4-3 was amended to 5-6-1-2-4-3, the change was announced, the inquiry sign extinguished and declared official.

Race 7

Following the running of the race an objection was lodged by Alyssa Morales, rider of unofficial second place finisher #2 Sapello La Fina against the unofficial winner #1 Precise Timing and her rider Kevin Orozco, alleging interference in the turn. After speaking to both riders, and reviewing the video replays, it was determined that there was also contact between the two horse coming out of the chut but was deemed mutual. Regarding g the objection in the turn it was determined that while tight, the #2 always had room, and the #2 made no significant movement inward. The objection sign was extinguished, and the original order of finish declared official.
